1	on January 1, 1942, and ending on December 31,
2	1990, may be treated as members of the Special Ex-
3	posure Cohort for purposes of the compensation pro-
4	gram if the President, upon recommendation of the
5	Advisory Board on Radiation and Worker Health,
6	determines that—
7	"(A) it is not feasible to estimate with suf-
8	ficient accuracy the radiation dose that the
9	class received; and
10	"(B) there is a reasonable likelihood that
11	such radiation dose may have endangered the
12	health of members of the class.".
