- 1 Be it enacted by the Senate and House of Representa-

- 4 This Act may be cited as the "Strengthening Tactics
- 5 to Obstruct the Population of Screwworms Act" or the
- 6 "STOP Screwworms Act".

3	The Animal Health Protection Act (7 U.S.C. 8301
4	et. seq.) is amended by inserting after section 10409A (7
5	U.S.C. 8308a) the following:
6	"SEC. 10409B. NEW WORLD SCREWWORM FLY REARING FA-
7	CILITIES.
8	"(a) In General.—Not later than 180 days after
9	the date of enactment of this section, the Secretary shall
10	begin construction on 1 or more modular New World
11	screwworm fly rearing facilities (referred to in this section
12	as 'covered facilities') in eligible areas described in sub-
13	section (c).
14	"(b) Facilities.—A covered facility shall provide
15	for—
16	"(1) the rearing of sterile New World
17	screwworm flies; and
18	"(2) the dispersal of sterile New World
19	screwworm flies to areas at risk of New World
20	screwworm fly infestation.
21	"(c) Eligible Area Described.—An eligible area
22	referred to in subsection (a) is an area of a State that
23	the Secretary determines to be—
24	"(1) at risk of New World screwworm fly infes-
25	tation due to the migratory pattern of confirmed de-

1	"(2) suitable for dispersal of sterile New World
2	screwworm flies reared at a covered facility estab-
3	lished under this section to additional areas at risk
4	of New World screwworm fly infestation.
5	"(d) Report.—Not later than 1 year after the date
6	of enactment of this section, and annually thereafter, the
7	Secretary shall submit to the Committee on Agriculture,
8	Nutrition, and Forestry of the Senate and the Committee
9	on Agriculture of the House of Representatives, and make
10	publicly available on the website of the Department of Ag-
11	riculture, a report that includes—
12	"(1) an analysis of the current threat posed to
13	agriculture in the United States by New World
14	screwworm flies; and
15	"(2) a description of—
16	"(A) the efforts being taken by the Sec-
17	retary to combat New World screwworm fly mi-
18	gration, including construction and operation of
19	covered facilities; and
20	"(B) the effectiveness of those efforts.
21	"(e) Authorization of Appropriations.—There
22	is authorized to be appropriated to the Secretary to carry
23	out this section \$300,000,000, to remain available until
24	expended.".
